BOARD RESOLUTION OF THE VILLAGE OF SOUTH BLOOMING GROVE, NEW YORK, ADOPTED NOVEMBER 8, 2021, AUTHORIZING THE SUBMISSION OF AN APPLICATION PURSUANT TO THE STATE'S WATER INFRASTRUCTURE GRANT PROGRAM AND MATTERS RELATED THERETO

Recitals

WHEREAS, the Village of South Blooming Grove, in the County of Orange, New York (herein called the "Village"), adopted a Bond Resolution on October 25, 2021 authorizing the construction of various water system improvements (the "Project"), at the estimated maximum cost of not to exceed \$6,000,000; and

WHEREAS, pursuant to said Bond Resolution, the Village appropriated \$6,000,000 for said Project and authorized the issuance of not to exceed \$6,000,000 bonds to finance the cost thereof,

Now therefore,

THE BOARD OF TRUSTEES OF THE VILLAGE OF SOUTH BLOOMING GROVE, IN THE COUNTY OF ORANGE, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than a majority of all the members of said Board of Trustees) AS FOLLOWS:

Section 1. The Board of Trustees of the Village hereby authorizes the use of any grant funds received on account of the Project to pay all or a part of the cost thereof and further authorizes an Authorized Representative (as hereinafter defined) to apply for grants, including grants provided as part of the State's Water Infrastructure Grant Program and other forms of assistance, including financing through the New York State Environmental Facilities Corporation (the "EFC"), to offset the local share of the Project.

Section 2. The Mayor, Deputy Mayor and/or Village Treasurer (collectively the "Authorized Representatives" and individually, the "Authorized Representative"), acting on behalf of the Village and with the advice of counsel, are hereby authorized to execute, on behalf of the Village, one or more WIIA grant applications, EFC applications and/or agreements

between the Village and EFC, relating to the Project. The Authorized Representatives are hereby authorized, collectively or individually, to take any and all other actions necessary in connection with the foregoing and all matters related thereto.
