Al Fusco explaining resolution. We have been working on it for quite some time. I had applied to the NYS Environmental Facility Corporation on your behalf over a year ago to get additional water monies above the \$10 million that we are actually spending right now in order to put forth another water tank to put in additional storage. Also replace all the lines in the existing district because as you know we have 30 to 40 water breaks a year. We’re going to replace all the pipes and in addition we are going to service the entire village and the district to be expanded to be the entire village. Your village is the only village in NYS that doesn’t have the same boundaries for the district as the village. That project was going to apply for the grant and loan in June. I ask just for now that you to be the lead agency so we have a resolution of intent for you to become the lead agency. At the next meeting what we hope you will do is make you the lead agency, do a negative declaration and do some other resolutions toward getting the grant.
