# PUBLIC HEARING CDBG GRANT

LOCAL LAW

CONSTABLE - PUBLIC SAFETY DEPARTMENT

**Call to order** Trustee Rosner called to open the public hearing, seconded by Mayor Kalaj, 5 Ayes: regarding proposed local law establishing Constable - Public Safety Department.

**Engineer Fusco** advised that this public hearing is for a proposed local law for a Village Constable. They would have statutory authority pursuant to the NYS Constitution and NYS Municipal Home Rule Law, intent and purpose to provide public health safety and welfare, he continued to discuss what was included in the proposed local law.

# **Public Comment (limited to 3 minutes per person)**

- Kelly Parzer stated, you want to have a constable, we have police officers that are willing to serve and protect us, so there is no need for that, we have no water, I woke up to no water, you don't think that's a problem? Your worried about Constables, when we have police officers guarding you right now. Waters not an issue for you. You, you, how much pot did you smoke today? You're stoned. Listen up, we need water, we need clean drinking water dude, we don't need constables. You guys are all clowns, you especially, oh I care about the people, respect, I care about the people, what people do you care about. No, I can't have a seat....you can all kiss my ass, kiss my ass, kiss my ass.
- O Bonnie Rum first of all she wonders where you get the money in the budget, you don't have the funding in your budget to take care of all the water that you get and the 2<sup>nd</sup> day garbage pick-up and you have the money to establish a police officer. You don't have the money in your budget, when you get audited, she doesn't know where the money is coming from, but to have police officers for one year, she doesn't know, the training alone, what it will cost you, who wants to be trained for one year and then they can be let go, this is a joke, are you going to also have a court, or are you going to allow the Town of Blooming Grove's Court, where are the funds, training, uniforms, finding the people, do they have to live here, for one year. What is the starter cost, where is the phone, where is the police station, you are pulling things from the sky and you have to pay for it and you don't have the funds now. The amount of lawsuits.
