# 1. Call to Order

## 2. Discussion on Referendum Results

Deputy Clerk Yitzchok Ekstein reported that on Monday, June 23, 2025, the Village held a special election/referendum regarding a proposed change to the timing of the Village election. The question on the ballot was whether to move the Village election date from the third Tuesday in March to the fourth Wednesday in October.

It was reported that the referendum passed with a majority voting in favor of the change.

**Resolution 1:** Deputy Mayor Abraham Weiss made a motion to formally schedule the village election for Wednesday, October 22, 2025, from 12:00 PM to 9:00 PM at Village Hall, 811 Route 208, Monroe, NY 10950, in accordance with the results of the June 23, 2025 referendum.

Second: Trustee Zalmon Rosner seconded the motion.

Vote: All present voted in favor. Motion carried unanimously.

**Resolution 2:** Trustee Yitzchok Feldman made a motion to appoint Joel Stern residing at 12 Holland Court, and Shmaya Spitzer residing at 329 Lake Shore Drive, South Blooming Grove, as Election Inspectors for the scheduled village election.

Second: Trustee Zalmon Rosner seconded the motion.

Vote: All present voted in favor. Motion carried unanimously.
